1.	As per above OM para 8 it has been clearly stated that the pay of promoted Sr. Stenographers / Assistants. Gr. I can be fixed on par with direct recruits only in case there is an element of direct recruit. CSIR has imposed ban on direct recruitment of Sr. Stenos till the year 2014. Even after lifting of ban on recruitment of Sr. Stenos there is not even a single recruitment of Sr. Steno in entire CSIR or in anyone of its labs up to the year of implementation of 7 CPC i.e., 2016. Therefore in case the above order is enforced in CSIR and its labs, it may be clarified whether the pay of Sr. Stenos promoted on or after 01.01.2012 will be directly fixed at Rs.17140/- in accordance with para 8 of above Ministry of Finance OM. 2.	Is the above orders applicable to Sr. Stenos/ Assistants. Gr. I who are promoted on Ad-hoc basis on or after 01.01.2006 and retire in the same Ad-hoc post.	NIL
